

1. Only Stronghand Shooting Range's TOXIC FREE ammunitions are used in the range.
2. Firearms allowed are legally registered PISTOLS, REVOLVERS only.
3. No REGISTRATION, no shoot.
4. The Range Officer SUPERVISES at all times, his command is absolute and final.
5. Actions must be kept OPEN except when firing.
6. Extreme crossfiring is NOT allowed.
7. Fast draw, or "hip" shooting is allowed only when Range Officer is present.
8. All firearms must be pointed DOWNRANGE at all times.
9. Firearms will only be handled on the FIRING LINE.
10. Keep your finger off the trigger until you are ready to shoot.
11. Make sure bullets will hit the BACKSTOP, not the ceiling or floor.
12. NO RAPID FIRE ALLOWED.
13. If your gun jams, leave it on the firing line, pointing downrange and ask for assistance from the RO.
14. Unload, open the action, remove the magazine and ground and/or bench all firearms during ceasefire.
15. Keep area TIDY with appropriate items needed for shooting only.
16. Good sportsmanship will prevail at all times. BAD CONDUCT WILL NOT BE TOLERATED.
17. No eating or drinking while inside the range.
18. Do NOT handle any firearm or stand in firing line where firearms are present if PERSONS ARE DOWNRANGE.
19. Make sure that ammunition is COMPATIBLE with the firearm being used. When in doubt about anything, ask the Range Officer present.
20. All persons entering the firing line must wear EYE and EAR PROTECTIVE gear.
21. This is a FAMILY ORIENTED range, conduct one's manner appropriately.
22. We reserve the right to refuse service to ANYONE whose sanity is in doubt.
23. Persons not complying with the above will be asked to leave and the proper actions will ensue.
26. Firearms not being used must be BAGGED and its safety on at all times.  
No live ammunition is allowed on the reception floor.  
The reception floor areas are:
  - Stairwells and walkways
  - Seminar room
  - Reception counter
  - Toilets
  - Kiss Kiss Bang Bang Café
  - Elevator
20. Allow Staff, Security, Range Officers and Co-Members to STRICTLY ENFORCE range rules, for the safety and good practice for all.

## **ASSUMPTION OF RISK, WAIVER, RELEASE AND INDEMNIFICATION AGREEMENT**

In consideration of being accepted as a member or guest of STRONGHAND SHOOTING RANGE and/or permitted to use its shooting range and facilities ("Premises"), I, the undersigned, hereby freely and voluntarily state that:

I hereby acknowledge and agree that target shooting, the use of firearms and the use of the Premises may be dangerous and may involve the risk of serious bodily injury, including death. I have full knowledge of the nature and extent of all of the risks associated with the use of the facilities,

including, but not limited to injuries resulting from intentional or inadvertent discharge of firearms by myself or others, or the failure or misuse of any equipment, whether owned and maintained by STRONGHAND SHOOTING RANGE or otherwise. Thus, I hereby assume all risks connected or related to the use of the premises and/or taking part in the activities on the premises, which include, but are not limited to, the discharge of firearms, the firing of live ammunition and/or instruction in the use of firearms.

Further, I hereby **WAIVE** for myself, and for my heirs, executors, administrators, and assignees any and all rights and claims for injuries, damages, losses and other actions or claims whatsoever, including, but not limited to, my injury, death, and/or loss or damage of my property (collectively "Claims") which I may have or which may arise, in any way whatsoever, against STRONGHAND ONE GUN CLUB, STRONGHAND SHOOTING RANGE, INC., its owners, shareholders, directors, officers, employees, agents and/or representatives (hereinafter collectively referred to as "STRONGHAND SHOOTING RANGE"), thus releasing and holding harmless STRONGHAND SHOOTING RANGE from and against such Claims, in connection with or in relation to my presence in or use of the Premises.

I also hereby agree to **INDEMNIFY, DEFEND, AND HOLD HARMLESS** STRONGHAND SHOOTING RANGE from and against any and all causes of action, fault, liabilities, expenses, claims, demands, lawsuits or costs of any nature whatsoever that any third-party may have which arises out of, is related to or connected with my presence at or use of the Premises, including any other act or omission on my part thereat.

I hereby represent and certify that I am in good health and that I do not have any physical, mental or emotional limitations that would preclude my safe and responsible use of the Premises.

I hereby undertake to abide by range rules and procedures and any other rules and procedures stated by the Range Officers and those representing STRONGHAND SHOOTING RANGE at all times.

I hereby acknowledge that I have read this instrument, which is in a language known to me, and I fully understand the terms and consequences hereof, and I am executing this instrument freely and voluntarily, intending to be legally bound hereof. I agree that this instrument is intended to be as broad and inclusive as allowed under Philippines laws, and that if any provision of this instrument is determined by final judgment to be invalid or otherwise unenforceable, the remaining provisions shall continue to remain in full force and effect.
